Introduction

IFAD's 41st Governing Council, held on 13 and 14 February, will focus on the theme *From fragility to long-term resilience: Investing in sustainable rural economies.*

Increasing numbers of people around the world are living in contexts that, for different reasons, may be considered fragile. Situations associated with relatively low institutional capacities, social and political instability, as well as - in some cases conflict, are reducing people's resilience to the shocks that emanate from climate and weather-related conditions, environmental pressures and adverse economic situations. Virtually all countries are affected to a greater or lesser degree by these challenges. The incidence of violent conflict is also at an all-time high, which is multiplying the numbers of internally displaced persons and refugees. These realities are undermining the prospects for sustainable development and threatening the livelihoods of the rural people IFAD works with.

Investing in sustainable rural livelihoods is central to peacebuilding, state-building and social stability. Rural communities are particularly susceptible to the drivers and impact of vulnerability and fragility because they rely on natural resources and risk-prone agricultural systems for their livelihoods and food security. In poor rural communities, this is exacerbated by inadequate infrastructure, weak assets and scant access to financial services.



Key questions for discussion

Interactive sessions will provide a platform for delegates to participate in discussions around questions that are critical for the future of IFAD and its contribution to achieving the Sustainable Development Goals, including:

- What approaches are needed to tailor investments to the needs of young rural people in vulnerable and fragile situations?
- What types of new financing mechanisms would enable IFAD to respond most effectively to the challenges faced in building resilience?
- What are the prospects for multilateralism to contribute to addressing the challenges faced by rural communities?


The Governing Council will take place in the Plenary Hall. Other conference facilities are located on minus 1 level and consist of:

Cafeteria facilities

Coffee, light beverages, sandwiches and pastries are available in the cafeteria on the ground floor and at the coffee bar on minus 1 level. The cafeteria will remain open until the end of proceedings on the days of the Governing Council session.

The cafeteria on the ground floor serves lunch from 12.00 until 14.30. A list of nearby restaurants and self-service cafeterias is available at the information desk.

Security

A security perimeter will be established around the meeting site. Strict security measures will be implemented at the entrance and inside the building. Metal detectors and x-ray machines for baggage scanning will be in operation at all entrances to the meeting site. Security staff are instructed to allow entry only to persons in possession of a Governing Council badge issued by IFAD.

To ensure the safety of all participants, badges must be displayed at all times in the venues. Under no circumstances should your badge be lent to another participant. Delegates are reminded to wear their badge at all times and never to leave briefcases or any valuable items unattended at the meeting site.

Banking facilities

A branch of the Banca Popolare di Sondrio is located on the ground floor. The bank is open from 8.30 to 13.30 and from 14.30 to 16.00.

Medical services

The IFAD medical team will be on the premises during the session. In addition, arrangements have been made with the Food and Agriculture Organization of the United Nations to provide other medical services, if required. Such services should be requested through the IFAD nurse (Room B035, ext. 2370).

Travel agency

Carlson Wagonlit Travel is located on the ground floor. It is open from 9.00 to 17.00.

Parking and transportation

Vehicles will not be allowed to enter the premises. Delegates may be dropped off in front of the IFAD Headquarters main entrance where the local authorities will be assisting with traffic control. An alternative parking area will be reserved at via Paolo di Dono 145 for vehicles in possession of diplomatic license plates.


Taxis from IFAD may be requested from the guardhouse at the main entrance.

A morning shuttle bus service is available from 7.40 to 9.25 between Laurentina metro station and IFAD headquarters. The evening service between IFAD headquarters and Laurentina metro station runs as follows:

- 13 February from 16.45 to 22.35
- 14 February from 16.45 to 18.50

The pick-up and drop-off point at Laurentina station is viale Luca Gaurico 9-11, on the main road behind the station, while the IFAD drop-off and pick-up point is the yellow bus stop adjacent to the main entrance of the guardhouse (between via Paolo di Dono 50 and 44).

H.E. Sheikh Hasina

Prime Minister of the People's Republic of Bangladesh

Sheikh Hasina assumed the office of the Prime Minister of Bangladesh in January 2009. She previously served as Prime Minister between 1996 and 2001. Sheikh Hasina has been awarded numerous honours, including: UNESCO's Félix Houphouët-Boigny Peace Prize (1998) for her contribution to ending the 23 years of conflict in Chittagong Hill Tracts; the Food and Agriculture Organization of the United Nations CERES medal (1999) in recognition of her fight against hunger; and the All India Peace Council "Mother Teresa Award" (1998).

Sheikh Hasina has been a strong advocate for the Culture of Peace at global, regional and national levels. Her initiative has resulted in the first-ever resolution by the Plenary of the United Nations General Assembly on the Culture of Peace. She has also provided leadership in the field of education. Her government has greatly enhanced budgetary allocation for primary education, with a focus on education for girls. At the United Nations and in other forums, she has been a major voice in support of the cause of children and their rights. She has authored several books including *Why are They Street Children*, *The Origin of Autocracy*, and *Miles to Go*. She graduated from the University of Dhaka in 1973. Since then she has received numerous honorary doctorates from universities across the globe.

José Berley Arista Arbildo became the Minister for Agriculture and Irrigation of Peru in January 2018. His former roles included Adviser to the Ministry of Economy and Finance; Executive Director of the Special Project of the Pan American Games; and the President of the Regional Government of Amazonas. He has also served as National Director of Public Budget and Deputy Minister of Finance in the Ministry for Economy and Finance. Before joining the Government, Mr Arista held positions with the *Banco de la Nación*, Andean Development Corporation (CAF) and the Inter-American Development Bank. Mr Arista has a bachelor's degree in economics from the Catholic University of Peru. He has a master's degree in economics from the University of California, Los Angeles.

We need to talk about state fragility

This year's IFAD lecture will be delivered by Mr J.J. Messner, Executive Director of The Fund for Peace, which presents the Fragile States Index, an annual ranking of 178 countries that tracks performance on social, economic, and political indicators. The lecture will be introduced by the Vice-President of IFAD, Ms Cornelia Richter.

Vulnerability and fragility can be sensitive topics – after all, no country wants to be known as a "fragile state". But the reality is that every country experiences fragility, and in today's interconnected world and globalized economy, state fragility affects us all in different ways. So what does state fragility actually mean? And how is fragility measured? This lecture will consider how data can better inform our understanding of underlying causes and trends of fragility and how to craft effective policy responses to improve resilience against challenges from climate change to social conflict.

From fragility to long-term resilience

There are a number of internal and external factors that can contribute to a country's fragility, jeopardizing its chances of eradicating poverty and achieving the Sustainable Development Goals. This interactive session will take a closer look at how IFAD, together with its Member States, is intervening in two specific countries to support sustainable rural economies. The session will review some of the factors that cause fragility, and will include discussion of tools and innovative approaches that have successfully built resilience in fragile contexts.

The goal of the g7+ is to help stop conflict, achieve peacebuilding and state-building and eradicate poverty through innovative development strategies. The g7+ also provides a forum for sharing lessons and experiences among fragile states to support each other in their self-led transitions from fragility to resilience.
- H. E. Said Hussein lid, Minister for Agriculture and Irrigation of the Federal Republic of Somalia.
- Ms Majida Mcheik, Chief, Programme Department, Ministry of Agriculture of the Lebanese Republic. Majida Mcheik is also a member of the Ministry's projects committee, which coordinates, studies and prepares projects and programmes, local and international.
 She is focal point for the Food Security Sector working group and a Food Security steering committee member in Lebanon within the Lebanese Crisis Response Plan.

A perspective on fragility

H.E. Dr Olusegun Obasanjo GCFR, Former President of the Federal Republic of Nigeria

Dr Obasanjo was the president of Nigeria from 1999 to 2007. He also previously led the African Union and the G-77, and was involved in numerous international mediation efforts in Africa. He is a passionate advocate for Africa's agricultural development and for creating opportunities for rural youth in Nigeria and across Africa. Dr Obasanjo is Chair of the Africa Food Prize and Chair of the Zero Hunger Forum in Nigeria.

Dr Obasanjo will discuss how to address fragility and build long-term resilience in different contexts. He will be introduced by the President of IFAD, Mr Gilbert F. Houngbo. The talk will be followed by a Q&A session.

Multilateralism: Opportunities and challenges

Global issues such as climate change, conflict, emerging technologies and pressures on natural resources shape and challenge the rural landscape and the resilience of rural communities. Mitigating the associated risks and taking advantage of the opportunities will create an ever-greater need for international cooperation. What are the implications for multilateralism and official development assistance in a context of increased need for collaboration, heightened competition for scarce public resources and single-state approaches? There is strong global interest in finding solutions to current and emerging issues that can build resilience, stability and peace during the 2030 Agenda implementation period.

Investing in rural youth

Across developing countries, young people are two to three times more likely to be unemployed. They are often excluded from decision-making and policy processes, and they lack access to resources, finance and employment. This affects growth, threatens political stability and can lead to uncontrolled migration. Young farmers are already effective agents of change: they are already diversifying agricultural production, adopting new technologies and entering remunerative value chains. This panel will discuss the challenges, opportunities and solutions involved in investing in the growing number of rural youth.

 and management committee member of the Myanmar Indigenous Peoples Network.
