The Sustainability, Stability and Security (3S) Initiative in Africa

3S is an inter-governmental initiative that aims to address the interlinked issues of climate resilience, youth unemployment and irregular migration in an integrated manner by focusing on agroecology and degraded land areas of the continent. Conceived and owned by African countries (with Morocco and Senegal as initiators), the 3S Initiative aims at mitigating the adverse drivers and structural factors that hinder people from maintaining sustainable livelihoods and compel them to leave their places of origin. To achieve this, the 3S Initiative works at jointly fortifying Africa's three critical endowments: its natural resources (sustainability), human resources (stability) and institutional resources (security).

What will the 3S Initiative do?

In a post COVID-19 world, the 3S Initiative will tackle the issues of climate resilience, employment and outmigration in areas affected by land degradation on the African continent.

To achieve this, the 3S Initiative is designed to:

- (i) make rural investments
- (ii) address economic policy changes
- (iii) promote innovative technical and financial solutions aimed at the rural youth.

It is expected that these actions will lead to durable improvements in the economic opportunities of rural communities most impacted by climate change, unemployment, migration and the exacerbating effects of the COVID-19 crisis.

Investments will support the following activities:

Protecting watersheds and sustainable land management

- Securing land access and land tenure rights through national governments
- Creating public infrastructure in rural communities
- Building and strengthening early warning systems to predict drought and other natural hazards
- Strengthening agricultural knowledge, for example, through farm extension services
- Providing technical assistance to develop landbased product value chains
- Designing financial incentives to farmers and enterprises in agriculture and forestry
- Mobilizing diaspora funding and educating people on investing remittances productively
- Undertaking analytical studies that can form the basis of evidence-based policy changes.

How will the 3S Initiative work?

The initial target of public resources for the 3S Initiative is US\$200 million per year for five years: US\$180 million is expected to come from official development assistance donors and 10 per cent from 3S countries in Africa. It is envisaged that a further US\$4 billion will be leveraged through engaging the private sector.

Proposals will align with IFAD country strategies, which in turn must reflect priorities established through national policy documents, specifically nationally determined contributions, national biodiversity targets and national land degradation neutrality targets under the United Nations Convention to Combat Desertification. Moreover, IFAD will coordinate to align country programmes and country strategy notes with 3S national coordination frameworks, national road maps or proof-of-concept projects that have been developed by 3S member countries.

How will success be measured?

Table 1 shows the objectives, outcome areas and targets for the 3S Initiative.¹

A call for action

The COVID-19 crisis has worsened many adverse trends in Africa including rising youth unemployment and migration, hunger, malnutrition and poverty.

Rather than small remedies, comprehensive policies are needed to tackle the causes of these issues. Solutions must deal with climate change adaptation, rural job creation and migration and mobility in a cohesive way.

Policies directed at restoring degraded cropland to its economic potential and improving secure land access for farmers have the potential to boost rural employment and create "rural growth centres". Such interventions are likely to attract private sector investment in new land-based jobs on- and offfarm, thus creating new opportunities that will help retain rural youth who might otherwise decide to migrate away or be exposed to extremist activity and terrorism. The outcome is a more climateresilient and circular rural economy at home.

Donor funding in the amount of US\$180 million per year for five years will allow the 3S Initiative to make these changes come to life.
