As Lead Specialist for Food and Agricultural Policy at the World Bank, he served as advisor to the Vice President for Africa. Between research and development finance, Dr.

Badiane taught Economics of Development in Africa at Johns Hopkins University's School of Advanced International Studies for many years.

MAcMAP-HS6 database on market access. He has carried out research on market access, global trade modeling, the economics of trade retaliation, and the relationship between trade policy and Research and Development. He has been Director of the Centre d'Analyse et de Traitement des Donnees Economiques (CATT) from 1996 to 2004, and of the Laboratoire de Recherche en Economie et Finance Internationales (LAREFI) in France from 2014 to 2016, and Chairman of the European Research Network on International Economics and Finance (2002-2004). He was also editor of Revue Economique, Economie Internationale – International Economics and Economic et Statistiques. Recently, he has been awarded the Alan A. Powell Award 2010, presented each year by the Global Trade Analysis Project (GTAP) to recognize outstanding service of a representative serving on the GTAP Advisory Board. He was also awarded twice the GTAP Research Fellow.
