Despite the accelerated need to digitize (i.e. the process of transforming information from a physical format to a digital version), in many instances, due to security issues or lack of focus on modernization, information and negotiations still happen through massive paperwork or emails trails. The pandemic has made these problems only more evident and the need to digitize and digitalize (i.e. the practice of utilizing technology to enhance corporate processes) more pressing.

Innovation and digital transformation or digitalization can prove highly effective in enhancing business efficiencies and results for an organization to optimize operations and corporate processes.

About the session

The increased need for digitalization prompted by the pandemic has resulted in accelerated digital transformation, which has brought many benefits but also perils as organizations become more vulnerable to fraud attempts and hacking attacks. Therefore, organizations must also focus on finding solutions that mitigate risks through the use of new digital technologies and a change in the way they do business.

In this context, IFAD undertook a reengineering of processes — one of which consisted in introducing digital signatures. This session of the IFAD Innovation Talks will feature a Fireside Chat between Advit Nath, Controller and Director of IFAD's Financial Controller's Division, and Hélène Papper, Director fo IFAD's Global Communications and Advocacy Division. Advit and Hélène will deep dive into IFAD's Basic Electronic and Secure Digital Signatures, and allow for discussion and exchange on how innovations can make corporate procedures more efficient and agile, while also ensuring the adequate level of security.

The event will aim to answer the following questions:

- What methodology informs the IFAD's Basic Electronic and Secure Digital Signatures?
- What is the thought process leading to the design of this kind of solutions?
- Which approaches can help ensure both agility and security when digitizing corporate processes?
- What could be the costs of distribution for this type of solutions?
- How can innovations like this be mainstreamed in the organization?
