Virtual national workshop

18 March 2022

Background. The Independent Office of Evaluation of IFAD (IOE) conducted the third Country Performance and Evaluation (CSPE) in the Republic of Indonesia, covering 2013 to 2021. The CSPE assesses the results and performance of country strategies, the lending portfolio, and non-lending activities. The main in-country mission was conducted in October 2021 and the draft report was shared with IFAD and the Government of Indonesia in January 2022. The report was then finalized in February 2022, taking into consideration comments from IFAD and the Government.

As a final step of the evaluation, a virtual national workshop will be co-organized by the Government of Indonesia and IOE, in close collaboration with IFAD's Asia and the Pacific Division (APR).

After the national workshop, the Agreement at Completion Point (ACP) is signed prior to the presentation of the CSPE at the 117th session of the Evaluation Committee in June 2022. The ACP summarizes the main CSPE findings and recommendations, which the Government of Indonesia (represented by the Ministry of National Development Planning) and IFAD (represented by the Associate Vice-President of the Programme Management Department) agree to adopt and implement within a specific timeframe. The role of IOE is to facilitate the preparation and finalization of the ACP, which will be included in the final report of the Indonesia CSPE.

Main objectives. The event will: (i) discuss the main findings, recommendations and issues emerging from the CSPE; (ii) reflect on opportunities and challenges in the IFAD-Government partnership and strategic priorities for IFAD's next country strategic opportunities programme; and (iii) agree to finalize and sign the evaluation's Agreement at Completion Point (ACP).

Connection and expected participants. The virtual platform used will be Zoom. Participants are expected from:

• **Government of Indonesia**: (a) Ministry of National Development Planning; (b) Ministry of Foreign Affairs; (c) Ministry of Finance; (d) Ministry of Agriculture; (e) Ministry of Villages, Disadvantaged Regions and Transmigration; (f) Ministry of Public Works and Housing; (g) Ministry of Environment and Forestry; (h) Ministry of Home Affairs; and (i) ongoing Project Managers.

- **IFAD**: (a) Programme Management Department (Asia and the Pacific Division); and (b) IOE
- **Partners**: (a) Development partners; (b) Civil society organisations; (c) Private sector partners.
